This is to inform that the above Management Unit under the Parent Company Sawit Kinabalu Group with RSPO membership number 1-0223-16-000-00 had appointed Intertek Certification International Sdn Bhd to conduct the Initial Certification/Recertification Audit/Surveillance Audit at Borneo Samudera Sdn Bhd -Kunak Palm Oil Mill & Supply bases, located at Tawau, Sabah. The audit will be conducted from 6 - 10 January 2025 against the requirements of:

- Malaysia National Interpretation (MYNI) 2019
- **RSPO Principles & Criteria 2018**

In brief, Borneo Samudera Sdn. Bhd. (BSSB) is a registered subsidiary company of Sawit Kinabalu Group (SKG). The company's main business activities are cultivating, processing, procuring, and trading of oil palm products such as Fresh Fruit Bunches (FFB), Palm Kemel, Crude and Refined palm oil products. Currently, SKG has over 65,000 hectares of planted areas in 36 plantations, 7 palm oil mills for processing, 1 refinery, a Kernal Crushing plant, and 2 bulking installation facilities throughout Sabah.
