**Invitation to comment on MSPO Annual Surveillance ASA-02 of IOI Corporation Berhad, Plantation Management Unit – Dynamic Plantations Berhad (Gomali grouping), Segamat & Tangkak (Johor), Bahau & Gemencheh (Negeri Sembilan), Durian Tunggal & Jasin (Melaka), Karak (Pahang), Malaysia**
